Dear Prime Ministers & Colleagues,

I started a lawcase against hostcountry the Netherlands with the International Criminal Court on 1 may 2007. You have been reading my websites. Update on the CD too.

International Criminal Court is NO longer a court of law

UN refuses to investigate on crimes against humanity taking place within the Presidents' & Prosecutors' Office.

President Phillip Kirsch, Prosecutor Luis Moreno Ocampo and other prosecutors of ICC are guilty of crimes against humanity themselves:

- They lie about everything you can think of. See all my letters since january 2008 addressed to ICC, EU & UN on www.desireestokkel.nl.

They torture me, because they don't want to press charges against the NL-parliament, Dutch Supreme Court & municipal Bloemendaal. They want me to die of exhaustion. Ignore all my letters of complaint; my warmings for a fast growing war, Worldwide. Employees of ICC do not care for National security or Worlds' security.

According to UNHCHR this is NO reason to start an investigation on war-crimes taking place within the highest Criminal Court on Earth.

I asked Ban Ki-moon to have the UN Security Council investigate on ICC.

He refuses to give my file to UNSC.

I explained that 'true terrorists' read my websites, what inspires them to create more terrorism Worldwide. It also endangers lives of NATO-ISAF-soldiers, people working for NGOs, Businesses...etc...

UN does not want to aknowledge that the World has NO COURTSYSTEM left, when the President & Prosecutors of ICC are free to be dictators.

They are the most powerful tyrants planet Earth has ever known! Can torture & kill anybody they don't need. And they do!

- When an individual brings evidence to ICC, they decide 'which value it has', without talking to the bringer or without consulting the Pre-chamber-judge, Assembly, EU & UN.
- They decide which statemember is 'guilty of crimes against humanity and needs to be brought to trail... or which dictator is free to stay in a powerful position in parliament'. Procedures are hidden for the public.
- Decide 'which talks are needed with statemembers without publishing the contents of these talks - and evidence - for the rest of the World'.
- Decide 'if victums are victums' without publishing all evidence they have against a statemember / suspect / perpatrator.
- Etc....

EU & UN have NO power left

Now the UN refuses to investigate on ICC, the result is that ALL activities of EU & UN related to security are completely useless. Every law/treaty/document/resolution is overruled by a few President & Prosecutor of ICC, free to be Worlds' most dangerous dictators.

'War against Terrorism' NO longer exists.

We have no definitions left for 'dictator & dictatorship'.

ICC is a Hitler-court, an assassination-centre where criminals & victims are killed based on subjectivity of President & Prosecutors.

NL is lawless country

Thanks to the UN-letters related to ICC, NL is completely lawless. When a NL-prosecutor, judge, lawyer ... or who so ever...wants to be a dictator... there is NO system left to stop them.

NL is dangerous to the World. Residents grow old.

You sign contracts with a group of 10.000 dictators working in close relationships with government & parliament, who all keep each other in a powerful position based on corruption & emotional blackmail.

They grow old and get a pension. They long for the buttlar-life. Materialism.

The younger generation can't read, write... and can't work with law.

In 10 years time all the contracts you have signed are worthless.

Besides, we have not enough 'young people' to feed the needs of the retired persons.

Hatred will grow between generations.

Older generations have left the young ones with war, pollution, shortage of rawmaterials, wasted energy & money on compagny/policies, no Fair Trade & Eko, bureaucracy...etc...

Young ones can't provide in the demands of the older ones. Contracts are worthless, education is low, open vacancies, import of guestworkers from warzones, more occupational hazards, highly corrupt legal system...and NO financial system left.

Police is retarded = can't read, write or listen. Have no knowledge on facts in files, laws or treaties. Make up stories to intimidate civilians with. Give a show on tv to prove 'they are working'.

NL-prosecutors work like dictators too.

12.5 % of all cases are dropped. We talk about heavy crimes; weapons, wounded bodies, rape, incest, robbery... This results in 12.5 % x 16.5 residents = more than 2 million civilians are lawless today. How many persons becomes lawless thanks to Civil- & Administrative court is unknown.

Lawyers are corrupt. You have to be upper-middle-class with money when you want a lawyer to work from truth, protecting your body & life.

NL-judges are STILL free to be dictator. This will NEVER stop , unless ICC judges in my case.

Political parties NEVER start lawcases against each other. Corruption. Individual dictatorship must stay hidden for the rest of the World.

NGOs - like Amnesty International - get payed from tax-money to lie about severe violations of Human Rights in NL.

Foreign countries

Despite the fact that criminal NL has both International Courts of Law, foreign countries still don't stop the fast growing dictatorship NL. You continue to close deals with highly criminal members of parliament, waiting for ICC to stop them. Reading my sites.

What are you waiting for?

In 10 years time there will be no-one left to whom you can talk, about your contracts.

And what if 'true terrorists' decide that NL is a beautiful country to start WOIII in? What are you going to discuss at the UN Security Council? Your wishfull-thinking?

I want you...

- To stop to close deals with members of parliament who want WOIII.
- In NL its impossible to start lawcases against misconduct. Demand an explanation of the parliament. Its caused by corruption between parliament and legal system.
- To demand new elections for parliament in NL, based on the truth from my ICC lawcase. Possible now you have my signed ICC-letter in your hand.
- To demand an investigation on warcrimes within ICC, conducted by the UNSC.
- To demand an invesigation on relationships between ICC and NATO or all other organisations.
- Demand the moving from International Courts of Law from NL to another country. Even in Turkey political parties start lawcases against each other to end conflicts with!

And...

I need a serious letter of you, which I can send to the Pre chamber judge of ICC personally. Need you to help me and the ICCjudge to bring my case to justice.

Or do you liked to be laughed at by President & Prosecutors of ICC, who overrule you from now on, constantly.
