Jamie Oliver,

You receive this letter by mail.

Although my ICC-case against NL for 'crimes against humanity is not closed, I do like to link you on **NLF-Fair Trade & Eko - 'things we don't talk about in NL- '.**

I am too poor to buy your book Ministry of Food, so have to settle for you on the Web.

One of your definitions of poverty?

'People have it all: mobiles, tv-plasma's...and more materialism.

But they can't eat healthy food or take care of each other'. You want to change this.

Wereld Natuur Fonds in NL has its own definition

I'd like to talk to you about another definition of poverty:

'People in Europe are - financially - too poor to move on to Fair trade & Eko.

This destroys planet Earth. We are running out of time'.

Farmers can't be profitable when they can't make enough money out of Eko-food, can't distribute knowledge on Eko-agriculture, worldwide.

Consumers can't stop slavery, pollution, healthcare problems, low-education, bankruptcy caused by the EU or malnutrition, when They've not enough income to buy Fair trade & Eko to pass reluctant multinationals & parliaments. Or when They're not educated by the Western media.

Lawless EU-individuals have to go to court for the removal of 'crimes against humanity from their private life in Europe, caused by local government/parliament'.

They're being boycotted by the media, therefore boycotted by the court-system itself.

Necessary economical & legal changes are never discussed. Not brought into good-practice.

Europeans who are lawless - live in extreme poverty - and who go to court to fight against it....

have the mentality to generate changes we need for the movement from the Old-fashion way of doing business to NLF-Fair trade & EKO.

Because they've unique Talents & Tools, they're being mobbed into death by politics, media & legal system. Evolution & Evaluation are banned, instead of Explored & Extended.

NGOs provide in misleading solution.

Thus:

NLF Fair trade & Eko starts with making individuals aware of their 1-persons-toko on a Extreme-large set of lines.

Individuals 'who have it all, but simply don't want to accept that Earth is without Oxygen in 30 years time' are not going to build NLFs. Not for themselves, kids or other civilians.

These people - most likely - recognize themselves in your definition of poverty.

When materialism falls apart, they feel poor.

Now I have to be careful! I am NL, not UK.

Trouble overhere is 'that the people grow old'.

The older generation will leave Earth within 30 years. Only caring for what I call: 'their Butler-lifestyle. They're not rich, but because 'they've worked all their lives, they're entitled to a comfortable lazy way of living until they die'.

These people don't understand that a large part of the younger generation is not going to be so lucky that they can say: 'I have worked all my life for a holiday-feeling'.

Lack of raw-materials. Lower standards for education take over in NL, now people are getting older....

Financial-crisis will hit the young ones first. Unemployment due to merges between multinationals.

We can make quite a list here....

What to do?

- Make more definitions of poverty in EU, based on legal valid facts.
I shall explain to you about the poverty of an unemployed single lawless mother with 2 kids in NL, year 2009.
- Make simple poor Europeans build evidence about their true lifestyle and make them fight for themselves against the government' = fight for a lifestyle in NLF Fair trade & Eko.

You've been working with this mentality when your claimed 'healty school-lunches'.
Well... The message doesn't come through in NL...

NL-ers are too lazy to take responsibility for their own misery; rather grow in self-pitty. And the local government Loves it! Becomes richer thanks to the mis-management with tax-money....

Individuals must accept that They've to mixture at home: ' - documents with written facts - lawbooks - psychology- nature - ', when they want to have enough Oxigen to survive Earth.

The older generation brought Kids & Young adults into this world, so they're obliged to live in a way that those bodies-soules-spirits have a healty life and die in humanity, too....

- Make the media Evolute & Evaluate = 'In NL one can never learn something from tv!'
We do get (more) medical programs, lately... But a lstandard of living in State of Law NL comes with a complete lifestyle anchored in legal systems. Legal topics are being ignored, mostly. Or broadcasted as 'sensation'. The solid NLFs are never explained to the people.

Result: Simple people stay too simple. They don't know how to improve standard of living, or they do know it..., but are being boycotted. Distribution of knowledge is not-done, overhere... Perhaps you can't believe it, but 'with the BBC you're much better of'.

- I don't have to say it to you, its in your skeleton:
'When you want to change earth for the better, you must replace Bad-behavior with Good-behavior'.

I have been trying this in NL since february 2002, only to discover that the International Criminal Court itself is just as corrupt as the NL-courtsystem and NL-parliament are...

Have to start all over. New people, new ideas, new solutions.
Impossible, because I am still lawless. Can't sign labour-contracts or child-care-contracts, for example. The municipal will not proceed on it, now ICC refuses to close my lawcase with an degree. This is what I call 'mentally torture, executed by ICC'.
Have to finish this lawcase first, for worldpeace.
Too many lawless people from other continents count on me....
ICC-employees want me death. Perhaps they're going to be lucky, I am soóóó tired!

Oké

NL-ers can not digest more than 3-5 pages. Time to finish.
First 'what I want of you'. Second, my financial situation

Jamie,

- We have to find a method to move on to NLF Fair trade & Eko on a large scale.
Synchronize UK & NL-poverty. Stop self-pitty.
Make people work with lawbooks in phase of life.
Only with evidence in our hands, we can make people-governments-parliaments build a new economical system that can actually stop 'wars for food'.

Make NGOs work from legal truth.

As long as NGOs refuse to work with NLFs against their own parliament or parliaments of other countries where they try to rescue lives, nothing will change.
There's too much favourism between NGOs & parliaments and Int. Courts of law.
Human right treaties are not brought into good-practice.....
Not even by prosecutors & judges who work for Int. courts.

- We waste 1 billion on food in NL. This could have been given to the poor. Even in NL. However it becomes non-recycled litter. Waste of labour, raw materials & Oxygen. NL is mentally ill: we need to think more intellectual before we start to build systems. And when we go to work, we must build..., not dream about the things we wish to build...

Another example:

Poverty stays in the family

= it flows from one generation to the next.....thanks to politicians & public servants...

In NL, it costs 500.000 euro tax-money to find a job for an unemployed person with kids. Childcare excluded....

Overhere, 'the municipal intervenes/interferes in everything, at the cost of human lives'.

We have more than 1 million unemployed when you cumulate ALL figures.

We have to go back to the system in which 'the employer offers a job and the unemployed searches for a job and finds it'.

GO AWAY.... municipal, with you expensive public servants who want lawcases for their personal promotion

The way the government handles 'poor families' causes learning-difficulties in kids.

- The economical-insanity claims:
'More production for more prosperity, especially to overcome the financial-crisis'.

Do you believe it? We need to slow down:

- Only produce & buy things we do need in Fair trade & Eko
- Upgrade the 2nd-hand-trade. In UK this world is more sophisticated than in NL!
Its time for an 'Haute Courture second-hand-world'.
Celebrities open a shop and sell goods to local poor people = poor prove that they are poor!
- Replace everthing that needs to be repaired & renovated with Fair trade & eko.
- Craftwork needs to be broadcasted in the media.
This is an excellent method 'to open up borders from other continents'
- We need to grow trees....
Knowledges on water-management for farmers needs to be distributed on the Highspeed frequency. (Egypt is on my website for water-management.)

Extra income if the Social security office wants to give it to me

- school costs Cician 150
- school costs Luther 300
- 'Free schoolbooks' 320
- 'Study-money Luther' 280
- social activities 2 kids 350
- social activities 1 adult 175
- study & job-finding = lawcase

- When you pay medical bills, you never know which extra medical costs the municipal is going to finance.

- You've to pay all your bills first, before you get any refund from the municipal.

Result = you can't get all the money you're entitled to have.

For example: Social activities.

When you've to pay your medical bills, you've no money left for sports. So you can not claim '175 for social activities'.

- The Social security office still has to pay me 756 euro's for Tax-office-mistakes from 2007... I can't hand over the official documents from the Tax-office yet, therefore the municipal keeps the money from me.

- You do hardly get any money when you've to go to court.

In 2008 & 2009 I will not get money for my lawcases.

I am still in a financial dept of 5000 euro's all due to lawcases and fights against Slavery.

Extra medical costs in 2009

- Therapist Luther 250
- Orthodontist Luther 1200-1500
- Dentist 1 adult 50
- New glasses 1 adult 365
- When I get an accident and end up in hospital, I have to pay 650 euro of the complete bill myself... My children are 100% insured for hospital-care.

Costs for food

- 300 euro per month, officially for 3 persons; we eat of 150 euro per month.

Costs for clothes, housekeeping & transport

- you've to buy everthing you need from 1690 euro income per month, for 3 persons
- In 2008 I had to wash by hand for 4 months, because I couldn't afford to buy a new washer...

Extra Trouble

- You never have enough money when you've to pay bills
- You're manipulated into financial depts by the government = 350 euro loss on interest
- I have to waste a lot of money on 'searching for people who want to help me with my ICC-case'...
