Since september 2006 Vatican & Bisdom Nederland are informed on the fact that Dutch members of parliament behave like war-lords.

In 2006 we all expected the Dutch Supreme court to judge on my file..., already in your possession and available on my websites.

For an unknown reason the highest court of law in Holland removes individuals from our community, by ignoring their lawcases. Our judges behave like terrorists.

Despite the fact that the Supreme court is also informed on the consequences of their attitude by me, namely: 'My file has to be judged by the International Criminal Court, when the Supreme court forces me to have myself tortured & murdered by the (local) government'.

ICC has to stop the act of terrorism of Dutch judges & members of parliament.

Since 1 may 2007 my lawcase is with ICC.

The prosecutor - mr. Serge Brammertz - who received my file, resigned.

I still don't know who will take over my lawcase against Balkenende & co.

ICC doesn't object against websites.

I assume Bisdom Haarlem & Priest Antoine Bodar have informed you.

I have to be very clear to you:

- The Dutch church discriminates me on my intelligence, I may not live from the truth. I'm only welcome in church as long as I lie about my lawless position, poverty & government-violence in my home... and on my body. Church-members & - leaders do not want to acknowledge my lawcases against Balkenende & Co, who behave like dictators. They rather be on the photo with these war-criminals to become famous & rich, instead of being honest about crimes against humanity committed by these politicians.
- What makes me very angry is the fact that the Dutch church-leaders 'thanked PM J.P. Balkenende & Co on Prinsjesdag - 21 september 2007 - for their social approach to poverty in the government-policy for the

coming years'.

- To me this means:

'Church-leaders in Holland hide valuable information for church-members and public. Because the media lies towards the people about lawcases against Balkenende & Co, church lies too....!

My file, with which individuals can protect themselves at home against a lawless life, more poverty and a civil war in Holland - imposed on us by our present members of parliament - it kept away from the public.

Church-leaders are now guilty of 'crimes against humanity', too.

They place themselves above national & international law, when they ignore the legal obligations of politicians. They even vote for these dictators, to make sure that they get a job in the parliament!

What do you think you are doing!?'

I want you to end these lies immediately. Church must tell the truth, even when the media lies. On the Cd you find 100% file as I send it to ICC.

I know you will receive this letter by mail about 8 october 2007 in the Vatican , but I publish it on my site today. I email this letter to Bisdom Haarlem, now.
